## CPA Membership

### CPA Member

**Fee:** Held CPA license 3 years or less – \$255  
Held CPA license more than 3 years – \$340

*Any person who is a certified public accountant (CPA) of Pennsylvania, another state or political subdivision of the U.S., or the equivalent of a CPA of a foreign country or its political subdivision.*

### CPA Educator

**Fee:** \$135

*Any person who is a certified public accountant (CPA) of Pennsylvania, another state or political subdivision of the U.S., or the equivalent of a CPA of a foreign country or its political subdivision, and is engaged in accounting education on a full-time basis at an accredited college or university.*

### Nonresident CPA

**Fee:** \$215

*A certified public accountant (CPA) of Pennsylvania who neither resides nor is employed in Pennsylvania.*

**Membership year runs May 1-April 30.**

**Dues rates are subject to change after membership year end, April 30.**

**Applications:** All applications for membership are reviewed by PICPA staff, who shall determine the eligibility of the applicant for membership. Each application for membership shall be accompanied by a remittance of the appropriate dues for the applicable class of membership, which shall (a) be returned in the event of the rejection of the applicant, or (b) become payment of the applicant's dues in the event of the acceptance of the applicant to membership for the period of time designated within the applicant's acceptance letter.

**Dues:** Each member's dues shall be determined on the basis of his or her status as of May 1 of each year. For members whose status may fall in more than one membership type, the rate of dues shall be the one applicable to his or her principal activity. A portion of your annual membership dues is allocated to your *Pennsylvania CPA Journal* subscription.

Dues are not deductible as a charitable contribution but may be deductible as an ordinary and necessary business expense. Any portion of your dues that can be attributed to activities defined by the Internal Revenue Service as "lobbying expenses," are not deductible. PICPA has determined that 6% of your dues are not deductible for income tax purposes.

**Half year proration applies for new applications submitted between Nov. 1 and Jan. 31 (except Accounting Affiliates and Student Affiliates).**

## Non-CPA Membership

### Student Affiliate

**Fee:** \$10

*A full-time college student majoring in accounting or a related field.*

### Accounting Affiliate

**Fee:** \$40

*Any person who has graduated from an accredited four-year college or university with an undergraduate or graduate degree in accounting (or a related field). Eligibility is limited to five years after graduation date.*

### Candidate for Admission

**Fee:** \$180

*Any person who resides or is employed in Pennsylvania and who has passed the entire CPA Exam in any state or political subdivision, but has not met the experience requirement.*

### Associate

**Fee:** \$340  
Educator – \$135

*Any person who works in the accounting field and has a bachelors degree.*

*Associate Educators meet the same criteria but are also full-time faculty at an accredited college or university.*

### Reinstatements

Former members, please note: applications for reinstatement must be submitted with dues for the year in which reinstatement becomes effective. Members who were terminated for non-payment of dues must add a reinstatement fee of \$50 to the current dues rate for your membership type, and may be subject to additional fees due to the PICPA at the time of his/her termination. Former members who resigned in good standing are not required to pay the \$50 reinstatement fee.
